**CHIEF OF POLICE REPORT:**

The Chief read the monthly report for October 2023. A total of 150 events: 7 Incidents, 9 Arrests, 7 Adult, 2 Juvenile, 4 Traffic Collisions, 18 Citations, 35 EMS.

Chief discussed successful Halloween patrol with Officers passing out candy. AVRPD Officer VanWhy coordinated Toys for Tots donations in each municipal building. Officer Wilford attended recruiting events for part-time officers.

2. Motion by Commissioner Kuhns authorizing the renewal agreement for the Departments' continued participation in the Allegheny County Project LifeSaver Program, 2<sup>nd</sup> by Commissioner Yaksich. Discussion regarding the program by Chief Naviglia. Sgt. Cummings has received the necessary training regarding the tracking device and procedures. Motion passed unanimously.
3. Discussion regarding promoting the Officer on the Civil Service List to full-time. Promotion, as included in the 2024 Budget, will be passed at the December 12, 2023 regular meeting.

**OLD BUSINESS:**

1. Solicitor Shaw discussed the options for tie votes, reorganization meeting in the month of February of even years and the suggestion of creating by-laws for the Allegheny Valley Regional Police Department.

**NEW BUSINESS:**




**ADJOURNMENT**
